HOUSEHOLD GOODS & PERSONAL EFFECTS

- Original Bill of Lading / AWB or Copy of Telex Release
- Clear copy of Passport (Signature and Picture Page)
 - Inventory (detailed) Signed by Shipper
- Full Contact Information
- Full Employment Information
- Owner does not need to be present for clearance as long as all docs are on hand upon arrival of shipment

■ PROHIBITED ITEMS:

- All food items (Dried food, spices, perishables, meats, liquids)
- Narcotics and dangerous drugs
- Pornography
- Misbranded articles
- Hazardous articles, fireworks
- Toxic and poisonous substances
- Endangered species and artifacts
- Rooted plants, flowers, soil, fruits and promulgative materials

VEHICLES

- Original Bill of Lading or Copy of Telex Release
- Full Contact Information
- Copy of Title or Authorization from Lien holder
- Copy of current Registration
- Copy of current Insurance Card
- Vehicle Condition Report from Origin
- Temporary Vehicle Permit upon arrival of vehicle which is obtained from DMV
- Full Employment Information
- Clear copy of Passport (Signature and Picture Page)

- Proof of Compliance Autos not meeting
 U.S. emission requirements should not be
 considered for import and will be shipped back
 at the owner's expense; Autos without proper
 requirements should be loaded separately so
 that they do not delay clearance.
- 4% duty owed on the value of the vehicle + the cost of the ocean freight. IF OWNED FOR LESS THAN 90 DAYS.
- Owner must be on Guam upon arrival of vehicle. It is required that the owner be present upon the vehicle's arrival because the owner must obtain a temporary vehicle permit from the local DMV. This document is required prior to entry into customs.

RESTRICTED ITEMS

• Firearms & Ammunition -- List of firearms with serial numbers; Bill of sale; Firearms registration; Firearms license. Guam Law allows persons to import up to 4 legally authorized firearms for their own use. Ammunition is strictly prohibited. Firearms loose loaded in a container should be loaded at the door or in crate number 1 if crated to allow easy access for inspections. Once inspected at CFS facility, the firearms must be immediately removed from the premises. Firearms should not be considered for importing.

• Wine and alcoholic beverages must be on a descriptive inventory. An individual 21 Years

- and older cannot bring in more than one (1) gallon (3.8 liters) of alcoholic beverages as an exemption or as a gift. Any amount of alcohol in excess of the exemption shall pay a 4% duty based on the value of the alcohol + the cost of the ocean freight of the entire shipment. Alcohol should not be considered for importing.
- Medicines and narcotics must be properly identified. Only normal required quantities are acceptable, provided they are supported by a prescription or statement from personal physician. Narcotics listed under Schedule I, II and III of the Controlled Substance Act are generally prohibited entry. Severe penalties imposed if imported contrary to law. Medicines and narcotics should not be considered for importing.

CUSTOMS FEES

*Shipments said to contain firearms are mandated to be held in a certified Container Freight Stations for inspection by Guam Customs, prior to release. A fee of \$1.00 per cube will be assessed for the ENTIRE shipment and billed by the CFS terminal to the Carrier or TSP.

Motorcycles/ 4 wheeler / Trailers are mandated to be held in a certified Container Freight Stations for inspection by Guam Customs, prior to release. A fee of \$1.00 per cube will be assessed by the CFS terminal to the Carrier or TSP.

Effective October 01, 2011, the first 4,000 lbs of sea cargo, to include a vehicle, will be assessed a \$75.00 fee for domestic shipments / \$125.00 for international shipments and a \$.0012 fee will be charged for every pound thereafter.

Effective October 01, 2011 the first 100 lbs of air cargo will be assessed a \$125.00 fee and a \$.0012 fee will be charged for every pound thereafter.
